How to reach the "Palazzetto dello Sport":

From the highway of Colleferro (A1 MI-NA) turn right and go straight for 350 mt. To the round point turn left and proceed till the next round point about 1,6 km on the SS 6 (Via Casilina). Continue for 740 mt till the next cross roads and turn left and again to the 1st on the left. Continue straight on and to the roundpoint stay on the right and continue till the traffic light, then go straight ahead for 400 mt and you will reach the palazzetto dello sport.

KUMITE RULES

1) COMPETITION RULES

Individual Kumite: direct elimination and repechage for 3rd places - 90 seconds effective - one Ippon - in case of draw, referees decision. For semifinals and finals in case of draw it will be kettei-sen for 90 seconds effective. The first recognized technique will determine the winner. In case of further draw: referee decision.

Team Kumite: direct elimination non repechage.

2) SCORES

Score system based on criteria of ippon and wazaari, no point system. Preference will be given to "effective techniques" even if they do not strictly meet ITKF rules criteria.

3) SANCTIONS AND WARNINGS

Total control of technique is strictly required. Penalties will be determined as follows:

Verbal warning

Official sanction (Hansoku Chui)

Disqualification (Hansoku)

SHUTO and HAITO techniques are not allowed in kumite match, finals included, till future different decision. In the mean time coaches are requested to teach the proper way to use these techniques (attak and defense as well) in order to be included in the future.

4) JOGAI

1st jogai: verbal warning

2nd jogai: official sanction (Jogai Chui) no wazaari corresponding will be given

3rd jogai: disqualification (Jogai Hansoku)

5) VICTORY

In case of no IPPON – HANSOKU – KIKEN is required referee decision “Hantei” according to the criteria to give the preference to positive technique over negative (penalties/sanctions).

6) TENTO / SAISHINPAN

Not considered.

7) TEAM KUMITE

Teams must be of 5 competitors plus 2 alternate, black belt.

Team with less than 5 competitors not allowed, not accepted to the accreditation.

Winner will be the team with the highest number of victories.

In case of draw there will be an extra match between one representative of each team, in case of draw we will proceed counting first of all the IPPON and then in the following order Wazari, Hansoku and Chui.

If still draw there will new extra kumite match between one competitor of the two team.

The disqualification of one competitor will not automatically result in the disqualification of the whole team.

KATA RULES

1. SYSTEM OF COMPETITION

A. Score

B. Obligatory Kata Nijyushiho – Sochin – Unsu

2. ELIMINATIONS

Competitors will be divided in 3 poules. For each poule will be selected a **TESTA DI SERIE** from results of (championship, Italian, ETKF, ITKF, ESKA).

First elimination: kata Nijyushiho.

From each poule the 6 best competitors will proceed to the second elimination with the kata Sochin. To the finals 3 best competitors of each poule.

Court of referee will be formed of 7 judges. For the score counting: the highest and lowest score will be deleted

3. FINALS

9 Competitors will be grouped in one poule to perform the Kata Unsu. Score. One court of 9 referees. For the total score counting the 2 highest and the 2 lowest score will be deleted
