Memorial "Sensei Gichin Funakoshi"

This year is the 50^{th} anniversary of the departure of O Sensei G. Funakoshi (1957)

Sensei Funakoshi was born in Okinawa in 1868, and he is considered by everybody the father of Japanese karate because he was the first person to introduce officially the Okinawa karate to mainland Japan in the 1922.

In particular the karate style he practiced (Shotokan Karate) is the most popular in the world because based on a scientific technical and methodological training method, also thanks to the engagement and endeavour of the great Masters that came after him.

The 39th Shotokan Cup is dedicated to the Memorial of G: Funakoshi Sensei dead in April 1957.

COMPETITION SYSTEM: ELIMINATIONS: Flags

1st round kata selected between: HEIA 2/3/4/5 and Tekki Shodan.

From the 2nd round till the qualification of 4 athetes (A B C D) kata selected from: BASSAI DAI, KANKU DAI, JION, ENPI, JITTE.

Repechage with kata selected from BASSAI DAI, KANKU DAI, JION, ENPI, JITTE till the qualification of 4 athetes (A1 B1 C1 D1) The 4 qualified athletes (A B C D) and the 4 from repechage (A1 B1 C1 D1) will

perform two kata (Gankaku and Bassai sho) scoring system.

The 8 qualified athletes will copete following the criteria of combining qualified and repechage for exemple: A – D1. B –C1. C – B1. D – A1.

The total score of the two matches will give the classification for the 2 finals. The athletes classified 1° 2° 3° 4° will compete in the final with 2 kata (Sochin and Unsu) and the winner will have the **Coppa Shotokan "Master" 2007 – Memorial "Maestro Gichin Funakoshi".**

The athletes classified 5° 6° 7° 8° will perform a final with a Tokui Kata and the winner will get the **Coppa Shotokan 2007 - Memorial "Maestro Gichin Funakoshi".**

KUMITE RULES

1) COMPETITION RULES

Individual Kumite: direct elimination and repechage for 3rd places - 90 seconds effectives- one Ippon - in case of draw, referees decision. For semifinals and finals in case of draw it will be kettei-sen for 90 seconds effectives. The first recognized technique will determine the winner. In case of further draw: referee decision.

Team Kumite: direct elimination non repechage.

2) SCORES

Score system based on criteria of ippon and wazaari, no point system. Preference will be given to "effective techniques" even if they do not strictly meet ITKF rules criteria.

3) SANTIONS AND WARNINGS

Total control of technique is strictly required. Penalties will be determinated as follow:

- Verbal warning
- Official sanction (Hansoku Chui)
- Disqualification (Hansoku)

SHUTO and HAITO techniques are not allowed in kumite match, finals included, till future different decision. In the mean time coaches are requested to teach the proper way to use these techniques (attak and defense as well) in order to be included in the future.

4) JOGAI

1st jogai: verbal warning

2nd jogai: official sanction (Jogai Chui) no wazaari correspondind will be

given

3rd jogai: disqualification (Jogai Hansoku)

5) VICTORY

In case of no IPPON – HANSOKU – KIKEN is required referee decision "Hantei" according to the criteria to give the preference to positive technique over negative (penalties/sanctions).

6) TENTO / SAISHINPAN

Not considered.

7) TEAM KUMITE

Teams must be of 5 competitors plus 2 alternate, black belt.

Team with less than 5 competitors not allowed, not accepted to the accreditation.

Winner will be the team with the highest number of victories.

In case of draw there will be an extra match between one representative of each team, in case of draw we will proceed counting first of all the IPPON and then in the following order Wazari, Hansoku and Chui.

If still draw there will new extra kumite match between one competitor of the two team.

The disqualification of one competitor will not automatically result in the disqualification of the whole team.
